Specification: The Dielectric Union shall be rated for 250 psi (ANSI B 16.39). The body and nut shall be steel with galvanized coat, the gaskets shall be EPDM, the insulator shall be nylon, and the tailpiece shall be brass.

Function: BEECO Style DU Dielectric Union Series is designed for installation and use on potable water lines. A dielectric union should be installed between pipes made of dissimilar metals to prevent the rapid acceleration of corrosion and deterioration in the piping system due to galvanic and stray electric current.

Features: BEECO offers Female Iron Pipe by both Female Iron Pipe and Copper sweat connections for connecting Iron Pipe to Copper Tubing. Individually factory certified to withstand a minimum of 600 volts.






